Sir/Madam,

This is in reference to the de-affiliation matter of Indraprastha Private ITI, Morena (PU23000558), discussed in the 29th SCAA Meeting, wherein a decision for de-affiliation of the ITI was taken by the SCAA (Ref.: Annexure-4, Sr. No. 7 of the Minutes of the 29th SCAA Meeting).

2. It has subsequently been observed that the reply submitted by the ITI in response to the observations/remarks of the 29th SCAA Meeting was inadvertently mentioned as late submission during processing of the case, which resulted in the de-affiliation decision being recorded in the 29th SCAA Meeting. However, the reply was received within stipulated period.

3. Accordingly, the relevant remarks in respect of Indraprastha Private ITI, Morena (PU23000558) in the Minutes of the 29th SCAA Meeting are being substituted with the following:

"A joint inspection of the ITI shall be conducted by the concerned State Directorate and RDSDE Madhya Pradesh to verify the removal of identified deficiencies as claimed by the ITI. The date of inspection shall be decided by the State Directorate in consultation with RDSDE Madhya Pradesh. The inspection report shall be submitted to the DGT within one month from the date of this communication for consideration in the next SCAA meeting.
