(Except Women Training) , Ministry of Skill Development and Entrepreneurship, namely:-	

- 1. **Short title and Commencement**. (1) These rules may be called the Directorate General of Training (Except Women Training), Ministry of Skill Development and Entrepreneurship, , Group 'B' Posts, Non-Gazetted, Recruitment Rules, 2022.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Number of posts, classification, pay band and grade pay or pay scale**. The number of posts, its classification, pay band and grade pay scale attached thereto, shall be as specified in columns (2) to (4) of the Schedule.
- 3. **Method of recruitment, age limit and other qualifications, etc.** The method of recruitment, age limit, qualifications and other matters relating to the said posts, shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualification No person, -
  - (a) who has entered into or contracted a marriage with a person having a spouse living;

or

- (b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said posts: provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rules.
- 5. **Power to relax -** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by an order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. **Saving** Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen, other backward classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

### In case of recruitment by promotion/ deputation / absorption, grades from which promotion / deputation/ absorption to be made. (11)

**Promotion:** - Stenographers Grade-II in the pay level-4 (Rs.25,500-81,100) with ten years regular service in the grade.

**Note 1**: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their senior shall be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or 2 years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

**Note 2:** For the purpose of computing minimum qualifying service for promotion, the service rendered on regular basis by an officer prior to the 1st day of January, 2016 or the date from which the revised pay structure based on the Seventh Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding pay or pay scale extended base on the recommendation of the Pay Commission.

**Deputation:** Officers holding the post of Stenographer under Central Government holding analogous posts on regular basis in the parent cadre or department; or (ii) with ten years regular service in the pay level - 4 {Rs.25,500-81,100} or equivalent.

**Note 1:** The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

**Note 2:** Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be 'Not exceeding 56 years' as on the closing date of receipt of applications.

**Note 3:** For the purpose of appointment on deputation or absorption basis, the service rendered on a regular basis by an officer prior to 1st January, 2016 (the date from which the revised pay structure based on the Seventh Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding pay level or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common pay level or pay Scale and where this benefit will extend only for the posts(s) for which that pay level or pay scale is the normal replacement grade without any upgradation
