**OFFICE ORDER**

Approval of the President is hereby conveyed for appointment of Officers as in Annexure I, to the post of Director (Junior Administrative Grade) of Indian Skill Development Service (ISDS) Cadre in the Pay Matrix Level-13 (Group A Gazetted) on a regular basis, in different panel years consequent upon review and regular DPC held at UPSC on 29.05.2023.

2. Officers included in panel for promotion and holding the post of Joint Director on regular bases, are required to assume charge to the post of Director and their regular appointment in the grade of Director will be effective only from date of assumption of the charge. They are required to submit the joining report to DGT(HQ) immediately.

3. Officers who are already holding the post of Director on regular basis, consequent upon promotion vide earlier orders dated 19.07.2017, 14.12.2018 & 29.05.2020 need not to join afresh.

3. Officers (included in regular panel of year 2021 & 2022) who were in service in the concerned panel year, but had retired subsequently or otherwise, have also been considered for inclusion of their name in the panel year list, in terms of Department's OM No. 2011/4/98-Estt.(D) dated 12.10.1998. However, they are not entitled for appointment as retired officers would not be available for actual promotion from the date of issuance of this order.

4. The officers who are presently on deputation, they may repatriate to the parent department to avail the promotion by submitting their willingness within 07 working days and report to DGT(HQ) within a period of 30 days from the date of issuance of this order.

5. The officers included in the earlier panel will be senior to the officer include in the later panel. The seniority of the officers included in the same panel, will be in the same order as mentioned in annexure I, irrespective of actual dates of their appointment to the grade of Director (JAG).
