Subject : Release of Grant-in-Aid to the State of **Jharkhand** for procurement of tools & equipment in four(4) ITIs under the Centrally Sponsored Scheme 'Skill Development in 47 Districts Affected by Left Wing Extremism'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to Rs.180.00 Lakh (Rupees One Crore and Eighty Lakh only) towards procurement of tools & equipment in four (4) ITIs in the State of **Jharkhand** under the Centrally Sponsored Scheme 'Skill Development in 47 Districts Affected by Left Wing Extremism', as detailed below:

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of Rs. 180.00 Lakh (Rupees One Crore and Eighty Lakh only) as grant-in-aid for procurement of tools & equipment to the State Government of Jharkhand is subject to the following terms and conditions:

- The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
- The sanction is valid for one year from the date of issue.
- Subsequent release of fund will be made only after receipt of Utilisation Certificate (UC) from the State Government and sufficient utilisation of fund, subject to availability of fund.
- Sanction of grant is strictly restricted to the admissibility as per the decisions arrived in the meeting of Expenditure Finance Committee (EFC).


4. The Jharkhand State is required to utilise the aid as per the guidelines of the scheme and furnish physical and financial progress reports as per the formats prescribed in the Implementation Manual.

5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, No.24(35)/PF-II/2012 dated 29-08-2014.

6. The expenditure is debit-able to the Major Head 3601.06.101.36.04.35- Grant-in-aid for creation of capital assets.

7. The amount of Rs.180.00 lakh (Rs. One Crore and Eighty Lakh only) may be transferred to Government of Jharkhand through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II(45/76/SC) Dated 22-02-1977.
8. Certified that no utilisation certificate is pending in respect of the State mentioned in the sanction order as per requirement.
9. This issues in exercise of the delegated powers and in consultation with the Integrated Finance Division, Ministry of Skill Development & Entrepreneurship vide AS&FA Dy. No.235 dated 27.04.2017.
10. The entry has been made at serial no. 5/2017 at page 02 of Register maintained for Grant-in-aid.


