Subject : Release of Grant-in-Aid to the State of **Jharkhand** for Establishment of ITIs & SDCs under the Centrally Sponsored Scheme 'Skill Development in 47 Districts Affected by Left Wing Extremism'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs.572.21 Lakh** (Rupees Five Crore Seventy Two Lakh and Twenty One Thousand only) towards establishment of 10 ITIs & 20 SDCs at the districts of Chatra, West Singhbhum, Palamau, Garhwa, East Singhbhum, Bokaro, Lohardaga, Gumla, Latehar and Hazaribagh as partial fulfillment of 2<sup>nd</sup> installment in the State of **Jharkhand** under the Centrally Sponsored Scheme 'Skill Development in 47 Districts Affected by Left Wing Extremism', as detailed below:

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of **Rs. 572.21 Lakh** (Rupees Five Crore Seventy Two Lakh and Twenty One Thousand only) as grant-in-aid for establishment of ITIs & SDCs to the State Government of Jharkhand is subject to the following terms and conditions:

- The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
- The sanction is valid for one year from the date of issue.
- Subsequent release of fund, if applicable, will be made only after receipt of Utilisation Certificate (UC) from the State Government and sufficient utilisation of fund, subject to availability of fund.
- Sanction of grant is strictly restricted to the admissibility as per the decisions arrived in the meeting of Expenditure Finance Committee (EFC).

4. The Jharkhand State is required to utilise the aid as per the guidelines of the scheme and furnish physical and financial progress reports as per the formats prescribed in the Implementation Manual.

5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, O.M. No.24(35)/PF-II/2012 dated 05-08-2016.

6. The expenditure is debit-able to the Major Head 3601.06.101.36.04.35- Grant-in-aid for creation of capital assets.

7. The amount of **Rs. 572.21 Lakh** (Rupees Five Crore Seventy Two Lakh and Twenty One Thousand only) may be transferred to Government of Jharkhand through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II(45/76/SC) Dated 22-02-1977.
8. Certified that no utilisation certificate is pending in respect of the State mentioned in the sanction order as per requirement.
9. This issues in exercise of the delegated powers and in consultation with the Integrated Finance Division, Ministry of Skill Development & Entrepreneurship vide AS&FA (L&E) Dy. No.314 dated 07.09.2018.
10. The entry has been made at serial no. 2/2018 at page 03 of Register maintained for Grant-in-aid.


