Minutes of the fourth meeting of National Cluster Evaluation Committee of Skills Strengthening for Industrial Value Enhancement

A meeting of National Cluster Evaluation Committee (NCEC) was held under the Chairmanship of Shri N.S.Garbyal, Deputy Director General on 12th February 2021 for selection of 19 Industry Clusters (ICs) under scale phase of STRIVE project through Video Conference.

Background

- 1) Under the project total of 30 Industry Clusters (ICs) would be selected pan India. In the pilot phase of Industry Apprenticeship Initiative (IAI) under STRIVE, 11 Industry clusters were selected from seven states.
- 2) Director General of Training (DGT) launched scale up phase on 20th May 2020 for selecting remaining 19 Industry Clusters from across India through competitive selection process. Total 364 IC applications were received from 25 States/UTs. Of which, 14 states found 93 IC applications meeting the qualifying criteria by State Cluster Evaluation Committee (SCEC) and recommended by their respective State Steering Committee (SSC) to DGT for national level evaluation.
- 3) 93 IC applications were evaluated as per NCEC evaluation matrix of the STRIVE manual. Further, selection parameters approved by Secretary, MSDE (Chairperson, National Steering Committee) for pan India representation of ICs were applied as under:
 - a. Select minimum one Industry Cluster (IC) in every state that has recommended Industry Clusters through State Steering Committee and evaluation at state level. This will ensure participation of all such states that recommended industry clusters to NPIU in scale up phase.
 - b. Selection to be capped for maximum of 3 clusters per state.
 - c. Selection of such ICs in states will be based on merit and their marks in descending order.
 - d. A wait list of 10 ICs will be created as backup inventory in-case of dropouts with capping of max two ICs per state based on their merit.

Discussion Outcomes

1) NCEC members discussed, deliberated and approved following 19 Industry Clusters under scale up phase –
