**SPEAKING ORDER**

**Sub: Complaint of Submission of forged/ illicit documents by 19 ITIs of West Bengal in Grading Phase-II exercise -reg.**

Complaint was received regarding submission of forged/illicit documents in Grading Phase-II exercise by 19 ITIs of the State of West Bengal on 08/07/2021 to this office.

2. The ITIs are under administrative control of State Government, hence the matter was forwarded to State of West Bengal for verification of documents submitted by these 19 ITIs in grading phase-II exercise vide letter MSDE-35(4)/ ITI Grading/ Phase-II/ 2020/G.I. dated 15.07.2021.
3. The State has submitted the report as follows:
  - a. Six documents are reported fake which pertains to Kaligunj Government ITI (GR19000204), Khatra Government ITI (GR19000178), Purbasthali-II Government ITI (GR19000163).
  - b. The reply is awaited for seventeen documents.
  - c. Address is not found for six documents.
  - d. Organisations are not ready to comment for two documents.
4. In view of the above, State of West Bengal is requested to complete the verification of documents mentioned in Para 3 (b) to (d) at the earliest.
5. The grading of 3 ITIs namely Kaligunj Government ITI (GR19000204), Khatra Government ITI (GR19000178), Purbasthali-II Government ITI (GR19000163) is hereby suspended and these ITIs would be treated as ungraded.
6. State of West Bengal is instructed to conduct the joint inspection of errant ITIs along with an Official of RDSDE West Bengal. RDSDE West Bengal is also instructed to nominate an officer for the joint inspection under intimation to this office.
