Subject: Sanction for release of funds to the State of Delhi for upgradation of Govt. ITI Pusa into Model ITI under the Scheme "Upgradation of Government ITIs into Model ITIs.

Sir,

This is in partial modification of earlier sanction order of even no. dated 22.07.2016 wherein an amount of Rs. 590 Lakh towards Central Share was sanctioned to the State of Delhi for releasing Rs. 295 Lakh (General: Rs. 228.63 Lakh, SCSP: Rs. 44.25 Lakh, TSP: Rs. 22.12 Lakh) as 1st installment of Central Share for upgradation of existing Govt. ITI Pusa to Model ITI Pusa under the Centrally Sponsored Scheme "Upgradation of Government ITIs into Model ITIs". Out of Rs. 295 Lakh, only Rs. 250.75 Lakh has been released to the State of Delhi vide above mentioned sanctioned order whereas Rs. 44.25 Lakh could not be released.

- 2. I am now directed to convey the sanction of the President of India for release of Rs. 44.25 Lakh (Rupees Forty Four Lakh and Twenty Five Thousand only) towards balance of 1st installment for SCSP Component. The equivalent 30% share will be borne by the State Government.
- 3. The bank details of **Delhi Skills Mission Society (Model ITI)**, Directorate of Technical Education, Maya Muni Marg, Pitampura is given below for electronic transfer of the sanctioned amount of Rs. 44.25 Lakhs during FY 2016-17.

The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.
- 5. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the NITI Aayog and Ministry of Finance.
- 6. Certified that no utilization certificate is pending (as first installment is being released) in respect of the State mentioned in the sanction order as per requirement.
