Sanction for release of funds to the State of Uttar Pradesh for upgradation of Govt. ITI Karoundi, Varanasi into Model ITI under the Scheme "Upgradation of Government ITIs into Model ITIs.

Sir,

This is in partial modification of earlier sanction order of even no. dated 19.07.2016 wherein an amount of Rs. 630 Lakh towards Central Share was sanctioned to the State of Uttar Pradesh for releasing Rs157.50 Lakh (General: Rs. 121.35 Lakh, SCSP: Rs. 33 Lakh, TSP: Rs. 3.15 Lakh) as 1st installment of Central Share for upgradation of existing Govt. ITI Karoundi, Varanasi to Model ITI under the Centrally Sponsored Scheme "Upgradation of Government ITIs into Model ITIs". Out of Rs. 157.50 Lakh, only Rs. 36.15 Lakh has been released to the State of U.P.i vide above mentioned sanctioned order whereas Rs. 121.35 Lakh could not be released.

- 2. I am now directed to convey the sanction of the President of India for release of Rs. 121.35 Lakh (Rupees One Hundred Twenty One Lakh and Thirty Five Thousand only) towards balance of 1st installment for General Component. The equivalent 30% share will be borne by the State Government.
- 3. The bank details of **Uttar Pradesh (Model ITI)**, Directorate of Training and Employment, U.P. Lucknow is given below for electronic transfer of the sanctioned amount of Rs. 121.35 Lakhs during FY 2016-17.
