 - v. All the purchases will be made in accordance with the State Govt. norms.
 - vi. Utilization of fund will be assessed by monthly progress report etc.
- vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.
- 4. The "Vocational Training Projects Implementation Society of Nagaland" is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.
