In reference to meeting held with DG(T), on 2^{nd} December 2021 and above cited reference, we are getting requests that students names are not showing in the portal for creation of eligibility. In this regard, it has been informed to you that following are the reasons for names not being showing in the portal:

- a) Attendance is being not filled by the ITIs in the portal
- b) Sessional marks have not been entered into the portal
- c) Previous year results have not been declared for the trainees, same has been communicated to all State directorate on 3rd December 2021
- d) Fee payment eligibility has not been created

It is also the responsibility of DGT that student interests are supreme to us and all efforts will be made to ensure that every student who are eligible to appear for the exam will be given sufficient opportunity. It is also requested from all ITIs to raise the ticket in NCVT portal instead of sending mails in case of any technical issue for early resolution.

In the above regard, it is also requested that States may set up helpline portal for ITIs/trainees and may issue necessary instructions in order to resolve their query and looking at paucity of time, urgent intervention and actions regarding the same shall be appreciated. It will be helpful if information regarding state helpline number along with nodal officer with their e-mail and phone numbers are also provided to DGT as per annexure -2.

Furthermore, to provide fair chance to the outgoing trainees who have not been able to clear the exam due to various reasons or failed in any subject, an opportunity will be provided again within a certain period of time instead of waiting for the entire period. DGT is taking steps to propose supplementary examination in the month of May & June 2022 as per Annexure-1. Suggestions from state governments towards this are invited and any decision regarding this shall be taken after the consultations with the states which will be communicated to you shortly.
