3. Admission in NSTIs may be allowed only 50% of affiliated units in case of two years courses so that NSTIs can take admission every year.

4. All the RDs/Principals/HoOs are to ensure CTS admission for only those affiliated trades where lab. with all equipment and faculty are available. It is advised to make concerted efforts for local admission such as: -

- ✓ Display of Banner at Institutes' entrance gate, advertise through local media, hoardings at prominent places, posters, and banner at secondary schools about the available training options available in each district.
- ✓ Provide appropriate counselling and guidance to the drop outs as well as prospective trainees about the career prospects after CTS training.
- ✓ Publicize through local channels, radios, print media and brochures.

5. All the Regional Directors/Principals/HoOs of NSTIs are also advised to carry out the CTS admission adhering to the schedule and update the details of admitted candidates on NIMI portal immediately and share the details with DGT everyday by 5:00 p.m.
