Subject: Exemption to the Computer Based Test (CBT) for Trade Theory (TT), Workshop Science & Calculation (WSC), and Employability Skills (ES) for First Year trainees of Two-Years Trade – reg.

1. The Directorate General of Training (DGT), Ministry of Skill Development & Entrepreneurship (MSDE) is at present conducting the All India Trade Test (AITT)--2021 for the following trainees of the Industrial Training Institutes (ITIs):

- Trainees of first-year trade of 2020-21 session (both CBT and conventional examination (Practical & Engineering Drawing (ED)
- II. Second year trainees of two-years trade of 2019-21 sessions (both CBT and conventional examination (Practical & ED)
- iii. First year trainees of two-years trade of 2020-22 session conventional examination (Practical & ED)

2. The matter of the conduct of the CBT for the trainees of first year of two- year trade, in view of impact of pandemic and the representations made in this regard by various stakeholders, has been examined.

3. The competent authority accordingly has approved the following:

 (a) Exemption granted to all first year eligible trainees of two-years trade of session 2020-22: If the trainee has passed the Practical & ED examinations of first year held in conventional mode recently, she/he will be declared passed for the first year.

(b) CBT examination fees of such trainees, if paid, will be adjusted in the second year CBT examination.

- II. State/UT Governments should ensure that the second year classes of session 2020-22 commence from 3<sup>rd</sup> January 2022.
- III. Since such first year trainees are being exempted from the examination for the subject of TT, WSC & ES; this will also affect the first year students of earlier sessions (2018-20 and 2019-21), who are awaiting their supplementary examinations to be held. Hence, these trainees would also be declared pass based on the marks obtained by them in the Practical & ED.
- IV. Notional marks for the subjects of TT, WSC & ES for the first year students as covered in paragraph 3 (I) and 3 (III) above would be awarded on the basis of marks obtained in ED, Trade Practical (TP) and Formative Assessment (FA).

4. It is to state that these exemptions (i.e., automatic promotion to second year) are being given to only those trainees who have passed in both ED (wherever applicable) and TP examination. Further, the examination for the second year of such trainees shall be conducted with the syllabus of second year of two-year trade.

5. This issues with the approval of Secretary, MSDE.
