Subject: Inclusion of ITI passed as an entry criterion to SSC qualifications

Sir,

In the 22nd meeting of National Skills Qualification Committee (NSQC) held on 19th December, 2018 it was decided that all Qualification Packs (QPs) developed by Sector Skill Councils (SSCs) may include:

- i. ITI (two years after class 8th) as an entry requirement wherever the eligibility is class 10th, and
- ii. ITI (two years after class 10th) as an entry requirement wherever eligibility is class 12th

2. All Sector Skill Councils (SSCs) are requested to comply with the above decision and make necessary inclusions in all their forthcoming qualifications being sent for NSQF alignment.

3. This decision is hereby also made applicable to all SSC qualifications which are already NSQF aligned.

4. It may however be noted that such approval does not lead to any kind of equivalency between ITI and academic classes of 10th and 12th except as an entry requirement for SSC qualifications in the relevant field/sector/stream.
