Subject: Mapping of existing labs of NSTIs with related SSC to run short term courses and also create as a hub to run training boot camps for India Skill competitors-Reg.

National Skill Training Institutes are conducting training programs under CTS and CITS in various trades, however response for admissions in few courses is very poor. As discussed in VC meeting held on 03.02.2022 with all RDSDEs/Principals of NSTIs under the Chairmanship of Secretary, MSDE, and decided that all NSTIs to become hub for short term courses for upskilling/reskilling for ITI pass out students and trainers and also become as a hub for running training boot camps to competitors of India Skill/World Skill competitions for optimal utilization of infrastructure.

Terms and reference of towards create hub for short term courses and also for training boot camps are as follows:

- i) RDSDE's/Principals of NSTIs will evaluate Sectors/ Brand for respective labs available in the NSTI from World Skill Competition list.
- ii) Evaluate the availability of resource of trainers, upgradation of equipment's/with the support of suitable Industry under CSR activity. NSTIs should try to utlise the regular faculty only and in case of shortage of staff in domain knowledge, guest faculty can be hired by respective NSTI for the course.
- iii) RDSDE's/Principals of NSTIs will coordinate with Sector Skill Council (SSC)/Industrial cluster of respective sector/trade to analyze the local industry demand with respective selected trades to engage the apprentices and also increase the employability in the state.
- iv) NSTIs to coordinate with the Sector Skill Councils (SSC)with respective sector/trade to prepare the guidelines/standards for conducting training boot camps to India Skill competitors.

Accordingly, all NSTIs are requested to provide information in the attached at Annexure-1 latest by 4th March 2022.
