Minutes of Meeting of National Level ITI Evaluation Committeefor Private ITI held on 28th Feb 2019 at 10.30 AM at Kaushal Bhawan, New Delhi

As per the Operations Manual for STRIVE, approved on 3rd January 2019 by the National Steering committee chaired by Secretary, Ministry of Skill Development and Entrepreneurship, MSDE, a National Level ITI Evaluation Committee (NLIEC) under the chairmanship of DDG(C &P) was constituted for selection of Private ITI, which met on 28th February 2019 at Kaushal Bhawan, Karol Bagh, New Delhi. The following officials participated in the meeting:

The NLIEC was convened to evaluate Institute Strategic Plan (ISP) received from eligible private ITIs on the online portal under Result Area-1 of STRIVE and funding requirements of the private ITIs as detailed in ISP.

Total of 150 private ITI(placed at Annexure-A) submitted ISP online through mobile app (Social Cop) as per deadline on 26th February at 11.59 PM and the same were evaluated as per parameters fixed by Operations Manual of STRIVE. One ISP submitted by Shri Datta Meghe Polytechnic ITC, Nagpur (Grading 1.22) was rejected as it was not eligible (Eligibility criteriagrading 2.5 and above) to apply for STRIVE.

After deliberations on various aspects of ISP the Committee decided to add the following criterion for selection of private ITI in addition to existing ones i.e composite score(Grading & ISP) of ITI

- 1. NCVT Enrolment of Trainee for ITI should be above 100
- 2. Pass rate must be 50 % and above
- 3. Only one ITI from each society will be considered for selection in first phase of STRIVE irrespective of final score/rank.

Based on the above parameters 47 private ITIs were shortlisted placed at Annex B.The committee was of view that as the selection of Govt. ITIs is still under progress, NPIU may take a final decision on number of Pvt. ITIs (range of 30 to 40) to be selected in Phase I under STRIVE from the above list (Annex B) based on Composite Score. NPIU may also undertake random tele calling to the proposed ITIs to verify their credentials.
