SOP: ITI Trainee Profile Verification Before Hall Ticket Generation

Objective: This page/ functionality is to give the ITI trainees an opportunity to verify/ raise corrections in their profile information including photograph before first time Hall Ticket generation

- Trainee to access his/her profile information using the page "Trainee Verification Before HT" under the tab Trainee. NCVTMIS Portal Link https://ncvtmis.gov.in/Pages/Trainee/TraineeGrievanceAuthenticatec_Befor eHT.aspx
- 2. Enter Trainee Name and Registration No.
- 3. Existing Email ID and mobile No. will be displayed to continue
- 4. Enter the OTP received on Email ID/Mobile No. to continue
- 5. Trainee can update his email ID/mobile no. if both the existing email ID and Mobile No. are wrong/not accessible
- 6. Trainee profile will be displayed with existing data w.r.t. eight fields of his/her profile information (See Annexure for details)
- 7. Trainee has to select each and every field for its correctness or raise correction by selecting the Incorrect field, if required.
- 8. In case of correction required, type the correct value, select the document to be uploaded.
- 9. Upload the required document (s) as per the selection in step-8
- 10. Submit Profile/correction.

- 4. Profile data correction would be effective only after physical verification of documents by ITI.
- 5. Hall Ticket would be generated based on the verified/corrected data through this page.
- 6. If any trainee fails to do verification or the authority fails to act in stipulated time window, Hall Ticket would be generated based on the existing data in the portal.
- 7. Profile grievance would not be accepted after result processing/ marksheet/ certificate generation
- 8. Last date for Trainee Profile Verification before HT is 30th June, 2022.
