Subject: - Revalidation of sanction for release of funds to the State of Jharkhand for upgradation of Govt. ITI Ranchi (Hehal) into Model ITI under the Scheme "Upgradation of existing Government ITIs into Model ITIs".

Sir,

It has reference to this Directorates Sanction letter no. DGET-35(4)/Model ITI-Jharkhand/2015-NPIU dated 04.01.2016 and DGET-35(4)/Model ITI-Jharkhand/2015-NPIU dated 30.03.2016 vide which the sanction of the President of India for Rs. 350 lakhs to the State Government of Jharkhand for Model ITI Ranchi (Hehal) into Model ITI under the Scheme "Upgradation of existing Government ITIs into Model ITIs".

- 2. I am now directed to convey the sanction of the president of India for revalidation of Rs. 350 lakhs (Rupees Three Crore Fifty Lakhs only) out of which not more than Rs. 256.25 lakhs (Rupees Two Crore Fifty Six Lakhs Twenty Five thousand only) is allowed for expenditure by State Government of Jharkhand for Govt. ITI Ranchi, Hehal under the centrally sponsored scheme "Upgradation of existing Government ITIs into Model ITIs". Since, state has already utilised Rs. 93.75 lakhs (Rs. 350 lakhs Rs. 256.25 lakhs) under the scheme.
- 3. The said amount should be utilised by Govt. of Jharkhand within a closure of project period. Any amount not spent by that time should be surrendered to the Central Government.
- 4. Other terms and conditions of the sanction order remains the same as mentioned in the sanction orders referred in Para 1.
- 5. The issues in exercise of the delegated powers in consultation with the AS & FA, Ministry of Skill Development & Entrepreneurship Dy. No. **452** dated **17.10.2018**.
