- 2. The accounts of all grantee institutions or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.
- 3. The release of Rs. 112.00 Lakh (Rs. One Crore and Twelve Lakh only) as grant-in-aid for operationlisation of ITI Kiphire in rented accommodation to "Vocational Training Projects Implementation Society of Nagaland" under the State Government of Nagaland is subject to the following terms and conditions:
  - i. The fund sanctioned is of Non -Recurring nature and shall be spent for Non Recurring purposes only.

ii. Utilisation Certificate should be submitted online only through EAT module of PFMS, component wise, year wise expenditure statement may be furnished immediately after utilisation.

- iii. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred, terms and conditions stated in Implementation Manual and utilisation certificate furnished by the State Government of Nagaland.
- iv. The Sanction is valid upto one year from the date of issue.
- v. All the purchases will be made in accordance with the State Govt. norms.
- vi. Utilization of fund will be assessed by monthly progress report etc.
- vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.
- viii. Once the construction of the ITI Kiphire is completed, the machines & equipment and furniture will be transferred to permanent location.
