Sir/ Madam,

This is to inform that in the meeting of Committee on "Norms and Courses" held on 26.06.2019, at 2.30 PM at Conference Room, 1st Floor, Employment Exchange Building, Pusa Complex, New Delhi wherein the proposal for **Opening of Institute for Training of Trainers to be run by State directorate in Government ITIs** as an agenda item 10 was discussed.

In session Aug 2019, the NSTI and IToTs already affiliated with DGT will run the CITS training for private candidates passed out of ITIs /Diploma/Degree holders who have cleared All India Common Entrance Test (AICET). At present there is no opening for the ITI, diploma and degree holders already employed in Govt. ITIs to undergo CITS training in NSTIs through this entrance & admission process.

The following is approved for implementation:

- This scheme of CITS may be opened for the Instructors already appointed in Govt. ITIs through selection process of the state directorates and are not eligible to appear in AITT of RPL under CITS due to less than 03 year experience as instructor.
- The regular instructor in Govt. ITI with Degree in relevant stream or Diploma in relevant stream are eligible for registration in this scheme:
- The scheme may be implemented in NCVT affiliated Govt. ITI which shall be treated on similar lines as Govt. ITOT after completion of Affiliation process by applying to DGT for affiliation and joint inspection.
- 4. The affiliation application should be applied to DGT against desired number of units of the affiliated trade in third shift running in the Govt. ITI. If there is no affiliation in third shift, then the Govt. ITI should surrender the same number of affiliated units of the concerned trade in first or second shift.
- 5. All the candidates of this scheme should be registered in NCVT CFI Portal.
