The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of <u>Rs.296.67 Lakh (Rupees Two Crore Ninety Six Lakh and Sixty Seven Thousand only)</u> as grants for establishment of new ITI at East Sikkim District in the State of Sikkim to "Vocational Training Projects Implementation Society of Sikkim" formed for implementation of the scheme under the State Government of Sikkim is subject to the following terms and conditions:

- i. The fund sanctioned is of Non -Recurring nature and shall be spent for Non Recurring purposes only.
- ii. Utilisation Certificate should be submitted online only through EAT module of PFMS, component wise, year wise expenditure statement may be furnished immediately after utilisation.
- iii. The next installment, if any, of the fund would be released after receipt of UC as per provision in form 12C in GFR 2017 on the basis of actual expenditure incurred, terms and conditions stated in Implementation Manual and utilisation certificate furnished by the State Government of Sikkim.
- iv. The Sanction is valid upto during current financial year i.e. 2020-21.
- v. All the purchases will be made in accordance with the State Govt. norms.
- vi. Utilization of fund will be assessed by monthly progress report, field visits, photograph/videos etc.
- vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.
- viii. A separate maintenance contract including annual white wash of building, repairs of all electrical nature, plumbing as required, maintenance of lawns, gardening, sports facilities etc. may be made part of the construction contract.

- Specific efforts to be made to increase enrolment of women, including publicity drives, education fairs in 1X. campuses etc.
- Specific physical and financial mile stones with corresponding half-yearly targets for their implementation may be provided. In the event of any slippage from adherence of these specific target at the end of every х. six months, monitoring division apprised of the reasons for slippage along with strategy to achieve the targets.
- Accessibility features must be provided in all new constructions. Old buildings must be retrofitted. This xi. must be adhered to irrespective of the presence/ absence of any student with disabilities.
- Possibility of disbursal linked indicators may be explored for new hostels. xii.
- A compulsory module in entrepreneurship may be added to all existing courses to provide capacity xiii. building for self-employment.
- Training / attachment with industry may be made essential. xiv.

4. The "Vocational Training Projects Implementation Society of Sikkim" is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.

5. The sanction relates to Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance- II Division OM NO.1(3)/PF-II/2001 dated 1.4.2010.

6. The expenditure is debit-able to the Major Head 2230.03.789.08.11.35- Grants for creation of capital assets and 2230.03.796.09.11.35- Grants for creation of Capital Assets as per para 1 above.

7. Section Officer (Cash Section)/ Drawing and Disbursing Officer, DGT, Ministry of Skill Development and Entrepreneurship will draw the amount sanctioned vide para 1 above for Rs.296.67 Lakh and pay Rs.296.67 Lakh to the below mentioned society by transferring electronically to the bank account of the society.
