NOTIFICATION

New Delhi, dated -----

- **G.S.R.** —In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of Directorate General of Training (Women Training), Deputy Director of Training and Joint Director of Training, Group 'A', Recruitment Rules, 2019, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Deputy Director of Training and Joint Director of Training in the workmen's unit as fixed by the Central Government under Women Training, Directorate General of Training, namely:-
- **Short title and commencement.** (1) These rules may be called the Directorate General of Training (Women Training), Deputy Director of Training and Joint Director of Training, Group 'A', Recruitment Rules, 2025.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- **Number of post, classification and level in pay matrix.** The number of post, its classification and level in the pay matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- **Method of recruitment, age-limit, qualifications, etc. -** The method of recruitment, age limit, qualifications and other matters relating to the said post, shall be as specified in columns (5) to (13) of the said Schedule.
- **4 Disqualification.** No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or (b) who, having a spouse living, has entered into or contracted a marriage with any other person, shall be eligible for appointment to the said post:
 - Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
- **5. Power to relax.** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- **Saving.** Nothing in these rules shall affect reservation, relaxation of the age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Note: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their senior would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

By deputation (Including short term contract basis):-

Officers of the Central Government or State Government or Union Territories or Autonomous or Statutory Organization or Public Sector Undertakings or University or Recognized Research Institution:

(A)(i) Holding analogous posts on regular basis in parent cadre or department;

or

(ii) with five years regular service in the grade rendered after appointment thereto on a regular basis in posts in Level-10 or equivalent in the parent cadre or department;

and

(B) Possessing the following educational qualifications and experience as under:-

Essential:

- (i) A degree in Engineering or Technology (Electronics and Communication, Information Technology, Computer Science, Fashion Designing) from a recognized University or Institute;
- (ii)Five years industrial or teaching experience in relevant field from any Government organization or University or Institution created by an act of Parliament or State legislature or autonomous bodies or PSUs of state or UT or Central Government.

Desirable:

- (i) Master of Business Administration from a recognized University or Institute.
- **Note 1:** The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed four years.
- **Note 2:** The maximum age-limit for appointment by deputation shall be not exceeding fifty six years as on the last date of receipt of applications. **Note 3:** The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation, similarly, the deputationist shall not be eligible for consideration for appointment by promotion.
