- 2. In this regard, it is informed that the data migration process of the NCVT-MIS portal to the SIDH platform is at an advanced stage. The provision for raising grievance for profile corrections (name, DOB, Father Name, Mother Name etc.) for CTS trainees admitted in year 2014 and later has already been made live on the SIDH Portal (Public Notice no DGT-18030/2/2024-O/o DIR (TT) dated 18th December 2025, copy attached). Moreover, generation of legacy e-National Trade Certificates (e-NTCs), for trainees admitted before year 2014 is also made live on SIDH.
- 3. However, the provision for regeneration of documents (marksheets and certificates) after profile corrections for trainees admitted in year 2014 and later, generation of legacy e-certificates for CITS and ATS AND corrections in legacy certificates for trainees admitted before year 2014 is expected to be made available on the SIDH Portal tentatively by 31st January 2026, instead of the earlier indicated date of 15th December 2025.
- 4. It has been noted that due to some profile discrepancies or due to not having final certificates, the employers and recruiting agencies are seeking corrected/final Certificates from these candidates during verification of documents.
- Therefore, employers/recruiting agencies are requested to consider candidates on the basis of the provisional certificates or marksheets available with them till issuance of corrected/final certificates generated from the SIDH portal tentatively by 31st January 2026.
