OFFICE MEMORANDUM

Subject: Compliance with the Judgment dated 16.10.2025 passed by the Hon'ble Court of Uttar Pradesh in Writ - C No. 9893/2025, Satya Prabha Private ITI vs. Union of India & Others (connected with Writ - C No. 9776/2025, Gazi Sarkar Pvt. ITI vs. Union of India & Others)-reg

Whereas, both the above subject writ petitions have been filed challenging the validity of impugned order dated 29.08.2025, passed by the Government of India regarding de-affiliation order of petitioners Industrial Training Institutes i.e. Satya Prabha ITC - Faizabad (PR09000916) and Gazi Sarkar Pvt. I.T.I. Faizabad (PU09001852).

- 2. Whereas, after hearing the contention of the parties, the Hon'ble Court has allowed the petition in part. The relevant para of judgment is extracted as hereunder-
- "15. Accordingly, the petitions are allowed in part. It is provided that the institutes, the State Directorate and DGT shall together ensure that the students who have already been admitted to the petitioners-institutes prior to 29.08.2025 shall be permitted to complete their course duration of two years and they shall be imparted proper education to enable them to complete the course. In case adequate faculty, infrastructure and other paraphernalia is not available in the petitioners institutes the students shall be shifted to some other nearby ITI where the requisite facilities are available."
- 3. That since the petitioner ITIs have been de-affiliated due to lack of requisite infrastructure, therefore, in compliance with the judgment dated 16.10.2025, and considering the future of the trainees, it has been decided by the DGT that the data of the trainees, claimed to have been admitted by both petitioner institutes before the issuance of the de-affiliation order dated 29.08.2025, shall be transferred from the State Admission Portal to the SIDH Portal. The following procedure shall be adopted for the said transfer process:
- 3.1 The petitioners shall submit the details of such trainees to the State Directorate, Uttar Pradesh, within 15 days from the date of issuance of this letter. The submission shall include each trainee's basic particulars, admission receipt number, and the amount of fees collected from them. The petitioners shall refund the collected fees to the respective trainees and inform them that their admission will be re-adjusted in nearby ITIs. The petitioners shall also furnish an undertaking to the State Directorate confirming that all fees and charges received from the trainees have been duly refunded, along with a list of trainees willing to seek admission in nearby ITIs.
- 3.2 Subsequently, the State Directorate shall identify **two to three** nearby DGT-affiliated institutes willing to admit these trainees against available vacant seats. The affected trainees may take fresh admission in such institutes based on their eligibility and upon payment of the prescribed fees.

- 3.3 Thereafter, the DGT shall facilitate the State Directorate in transferring the data of these trainees from the State Admission Portal to the SIDH Portal, for the purpose of generating their Permanent Registration Numbers (PRNs).
- 3.4 It is further clarified that it shall be the sole responsibility of the petitioner institutes to refund the fees and return all original documents collected from the trainees, if any, at the time of admission. The DGT shall not be held responsible for any dispute arising between the petitioner institutes and their trainees in respect of fees, documents, or any other related matters in future.

This issues with approval of the competent authority in compliance with the judgment dated 16.10.2025 passed in the WRIT - C No. 9893/2025 Satya Prabha Private ITI Vs Union of India and Ors (Connected with WRIT - C No. 9776/2025 Gazi Sarkar Pvt. I.T.I. Vs Union of India and Ors).
