**Sub: De-Affiliation/Self -Surrender order of trade/units of 25 Private ITIs of Rajasthan State- regarding.**

Madam/Sir,

This is in reference to minutes of meeting of 9<sup>th</sup> and 10<sup>th</sup> Skill Development and Entrepreneurship Committee (SSDEC) of Rajasthan State held on 17.09.2025 and 23.09.2025, respectively, vide which the de-affiliation of trades/units of 26 Private ITIs was recommended based on self-closure requests submitted by the ITIs in the State of Rajasthan and was forwarded to DGT.

The matter was discussed in 25<sup>th</sup> Standing Committee on Accreditation and Affiliation (SCAA) held on 13.11.2025 to 14.11.2025 and it has been observed that the Prem Pvt. ITI (PR08000260) has already been de-affiliated vide DGT order dated 17.01.2025 due to zero admissions. Therefore, based on the recommendations of SSDEC, SCAA has accepted the request for de-affiliation of trade/units of 25 Private ITIs w.e.f. session 2025-26, and same has been approved by the competent authority. The details of 25 ITIs are attached at *Annexure - I*.

The Institutes and the State Directorate shall ensure that all the trainees who were already enrolled in the previous sessions, complete the training duration and no fresh trainees are admitted.
