Sir,

This is in supersession to the even No. Sanction Order dated 23.06.2021, I am directed to convey the sanction of the President of India to release an amount of Rs. 0.5865 crore (Rupees Fifty Eight Lakh Sixty Five Thousand only) towards 30% amount on KPI achievement i.e. "Reducing of trainer vacancy in govt. ITIs" of the fund allocated to the State for incurring the expenditure under the component Result Area 2 (RA-2) - Increased capacities of State Governments under the project "Skill Strengthening for Industrial Value Enhancement (STRIVE)" with World Bank assistance.

  - (i) The grant shall be utilized for the activities mentioned in the Operations Manual for Result Area -2 and no portion of it shall be spent on any other purpose.
  - (ii) The grant should be utilized before close of project STRIVE and any amount not spent by that time should be surrendered to the Central Government.
  - (iii) The conditions mentioned under PBFA should be adhered to during project implementation.
  - (iv) It should be ensured that the agreed documents as per Disclosure Management Framework are disclosed on the website of SPIU/State Directorate.
  - (v) All documents must be retained by the State Govt. for post review by the World Bank.
  - (vi) Utilization Certificate in Form GFR 12-C of GFR 2017, indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.
  - (vii) State of Nagaland, vide letter no.DESE-10/82/2019 dated June 2021 has confirmed utilization of central share of Rs. 0.67 crore out of Rs. 0.69 crore released to them for 30% advance on signing of PBFA prior to the fund being released now. (Copy of U/c attached).
  - (viii) Utilization Certificate of remaining release Rs. 0.5865 crore for Reducing of trainer Vacancy will be due within twelve month of the financial year or before March 2022.
- There are no adjustment of Previous Balance in the current Release.
- 6. The Grant is Non Recurring Types and noted at Serial No.21 FY 2021-22 in the Register of Grants placed in the NPIU Section.
