  - (ii) The grant should be utilized before close of project STRIVE and any amount not spent by that time should be surrendered to the Central Government.
  - (iii) The conditions mentioned under "Memorandum of Understanding" (MoU) should be adhered to during project implementation.
  - (iv) It should be ensured that the agreed documents as per Disclosure Management Framework are disclosed on the website of SPIU/State Directorate.
  - (v) All documents must be retained by the State Govt. for post review by the World Bank.
  - (vi) Utilization Certificate in Form GFR 12-C indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.
  - (vii) Annual Audited Financial Statements of the project should be submitted within 4 months after the end of each fiscal year.
- 5. There are no adjustment of Previous Balance in the current Release.
- 6. The Grant is Non Recurring Types and noted at Serial No. 25 FY 2021-22 in the Register of Grants placed in the NPIU Section.
- 7. State of Himachal Pradesh has confirmed utilization of central share of RS 51 Lakhs out of Rs 51 Lakhs released to them prior to the fund being released now (U.C. attached)
