 - (vi) Utilization Certificate in Form GFR 12-C indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.
 - (vii) Annual Audited Financial Statements of the project should be submitted within 4 months after the end of each fiscal year.

- 6. The Grant is Non Recurring Types and noted at Serial No. 26 FY 2021-22 in the Register of Grants placed in the NPIU Section.
