 - (iii) The conditions mentioned under "Memorandum of Understanding" (MoU) should be adhered to during project implementation.
 - (iv) It should be ensured that the agreed documents as per Disclosure Management Framework are disclosed on the website of SPIU/State Directorate.
 - (v) All documents must be retained by the State Govt. for post review by the World Bank.
 - (vi) Utilization Certificate in Form GFR 12-C indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.
 - (vii) Annual Audited Financial Statements of the project should be submitted within 4 months after the end of each fiscal year.
- 5. State of Gujarat has confirmed utilization of central share of RS 51 Lakhs out of Rs 51 Lakhs released to them prior to the fund being released now (U.C. attached)
