Sir,

I am directed to convey the sanction of the President of India to incur an expenditure not exceeding **Rs. 10, 05,000/- (Ten Lakh Five Thousand only)** towards lump sum pay of the staff working in the State Project Implementation Unit (SPIU) in the State of Gujarat under the Project "Skills Strengthening for Industrial Value Enhancement (STRIVE)" with the World Bank assistance.

2. A sum of **Rs. 10.05 Lakh (Ten Lakh Five Thousand only)** is being released to meet administrative expenditure for SPIU, as indicated in the Operational Manual, as per break up given below.

4. The release of abovementioned Central fund in respect of the said scheme is subject to the guidelines mentioned in the Operational Manual, Procurement Section and Financial Management Section along with the following conditions:

- (i) The grant shall be utilized for the purpose mentioned above for SPIU and no portion of it shall be spent on any other purpose.
- (ii) The grant should be utilized before close of project STRIVE and any amount not spent by that time should be surrendered to the Central Government.
- (iii) The conditions mentioned under "Memorandum of Understanding" (MoU) should be adhered to during project implementation.
- (iv) It should be ensured that the agreed documents as per Disclosure Management Framework are disclosed on the website of SPIU/State Directorate.
- (v) All documents must be retained by the State Govt. for post review by the World Bank.
- (vi) Utilization Certificate in Form GFR 12-C indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.
- (vii) Annual Audited Financial Statements of the project should be submitted within 4 months after the end of each fiscal year.

5. State of Gujarat has confirmed utilization of central share of RS 51 Lakhs out of Rs 51 Lakhs released to them prior to the fund being released now (U.C. attached)


6. This issues in exercise of the delegated powers in concurrence with the IFD, Ministry of Skill Development & Entrepreneurship vide Dy. No. E-FTS 34449 dated 27.01.2021 and approval of Secretary, MSDE vide FTS No. 34449 dated 28.01.2021.
