 - (iii) The conditions mentioned under "Memorandum of Understanding" (MoU) should be adhered to during project implementation.
 - (iv) It should be ensured that the agreed documents as per Disclosure Management Framework are disclosed on the website of SPIU/State Directorate.
 - (v) All documents must be retained by the State Govt. for post review by the World Bank.
 - (vi) Utilization Certificate in Form GFR 12-C indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.
 - (vii) Annual Audited Financial Statements of the project should be submitted within 4 months after the end of each fiscal year.
- (viii) State of Odisha, vide Memo no. 20 CT-II-STRIVE-SPIU/03/2020/647 dated 19.1.2021 has confirmed utilization of central share of Rs. 17.94 Lakh out of Rs. 20.00 released to them for SPIU. (Copy of U/c attached).
- 5. There are 6.59 Lakh adjustment of Previous Balance in the current Release.
- 6. The Grant is Non Recurring Types and noted at Serial No.58 FY 2020-21 in the Register of Grants placed in the NPIU Section.
