 - (iv) It should be ensured that the agreed documents as per Disclosure Management Framework are disclosed on the website of SPIU/State Directorate.
 - (v) All documents must be retained by the State Govt. for post review by the World Bank.
 - (vi) Utilization Certificate in Form GFR 12-C indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.
 - (vii) Annual Audited Financial Statements of the project should be submitted within 4 months after the end of each fiscal year.
- (viii) State of Arunachal Pradesh has confirmed utilization of central share of Rs. 15.71 Lakh out of Rs. 15.71 Lakhs released to them for SPIU under VTIP. (Copy of U/Cs attached).
- There is no adjustment of Previous Balance in the current Release.
