Reference: Consultation Meeting with the state Directorates on All India Trade Test  
for CTS (AITT -2021) held on 08-Nov-2021

Sir/Madam,

With reference to the above subject, it was discussed that all the State Directorates shall ensure that the eligibility criteria i.e. attendance, upload of formative marks and practical exam fee shall be entered by the respective ITIs on or before **30<sup>th</sup> November 2021. Portal will be closed on 30<sup>th</sup> November 2021 at 11:59 p.m. strictly for this activity.**

**2.The trainees eligible for payment of CBT exam fee should meet the following criteria**

- a) Attendance should be above the minimum criteria prescribed by the DGT as per orders issued from time to time
- b) Minimum Pass marks in the formative assessment /sessional as per the data entered in the portal.

3. For payment of CBT Exam fees, as many states have expressed their difficulties in bulk payment, it is decided to **allow the ITIs also, to pay the CBT exam fee on behalf of trainees directly in the NIMI portal** ( payment link of NIMI will be made available in NCVTMIS portal).

4. For those States that wish to make bulk payment on behalf of ITIs in their state can make payment to NIMI account either online payment or direct account transfer (e-payment/challan etc.) and provide the details of students whose payments have been made to NIMI through excel file.

The payment through portal shall be allowed only for ITIs/States for online payment.

5. The fees to be deposited for Computer Based Test (CBT) for theoretical subjects as follows:

For regular trainees: Rs. 376/- per trainee


Note : For Old trainees (supplementary examination): separate notification will be issued later.

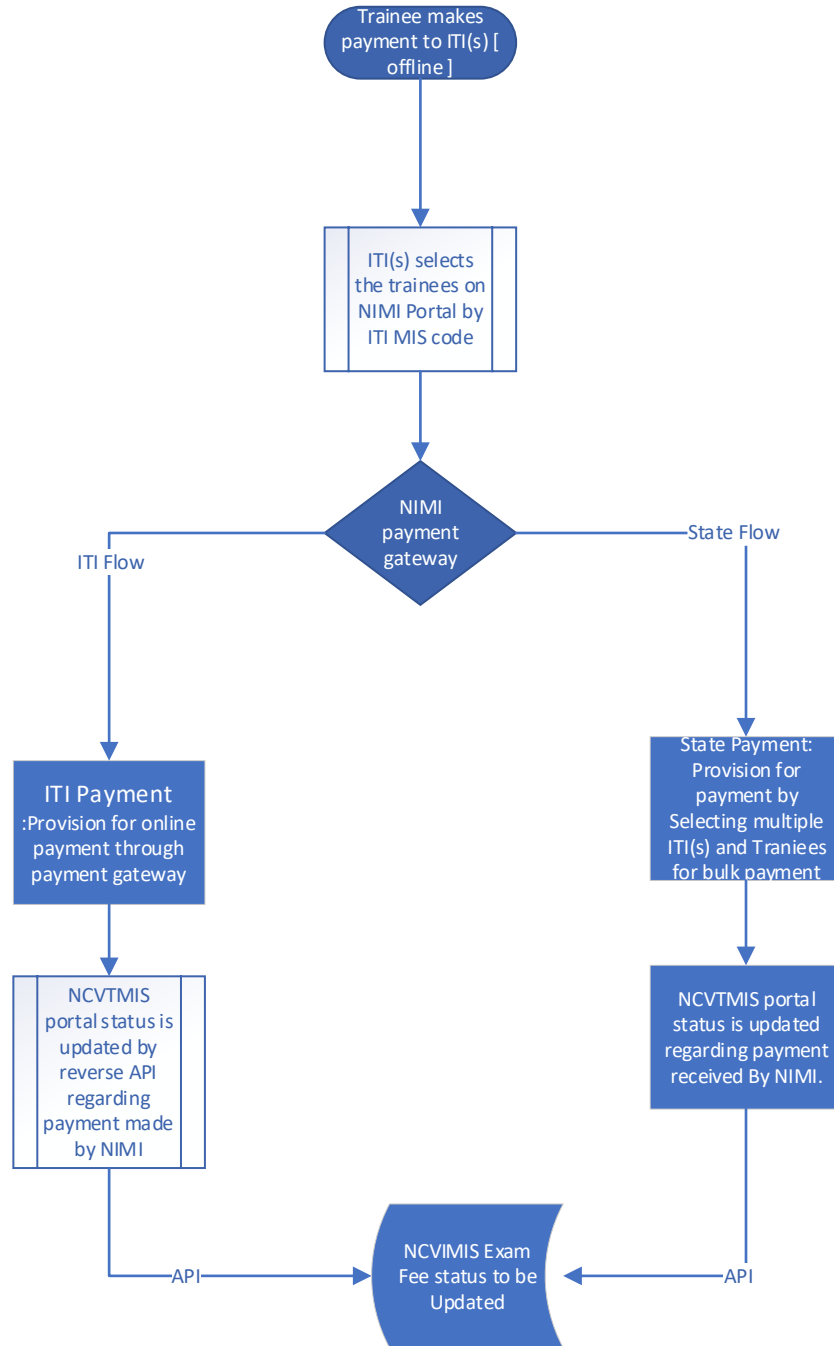
**Subject : Exam Fee communication between NCVT-NIMI Portal for generation of hall ticket for CBT exam.**

**i) Entity wise Action**

<b>Actions</b>	<b>Process Flow</b>
Trainee	Trainee /candidates makes payment to the ITI(s) offline.
ITI(s)	<ul style="list-style-type: none"><li>ITI(s) updates the eligible candidates details on the NCVIT portal (session marks, attendance).</li><li>NIMI gets ITI wise trainees details via API from NCVTMIS.</li><li>ITI's shall make exam fee payment by selecting the trainees <b>on NIMI portal</b></li></ul>
NIMI	<ul style="list-style-type: none"><li>ITI Flow: NIMI shall have provision for payment by ITI directly through payment gateway and update the status in the NCVTMIS portal by reverse API regarding payment made .</li><li>State Flow: The states also shall the have the provision to make bulk payment in the NIMI portal directly by selecting multiple ITIs and trainees as some states are ready to make payment through online payment gateway or direct payment (e-payment/challen).</li><li>Once payment is made, the payment status of the trainee shall be updated in NCVTMIS via reverse API</li></ul>
NCVTMIS	<ul style="list-style-type: none"><li>Will share the eligible trainees who have paid the exam fee to NSEIT for centre mapping via API.</li></ul>
NSEIT	<ul style="list-style-type: none"><li>NSEIT shall do the center mapping against the fee paid by the candidates and share the same with NCVTMIS through API#.</li></ul>
NCVTMIS	<ul style="list-style-type: none"><li>On receipt of the centre mapping data from NSEIT, the Hall ticket for the respective candidates will be generated and made available in the NCVTMIS portal for trainees / ITIs.</li></ul>
