Subject : Release of Grant-in-Aid to the State of **Chhattisgarh** for establishment of 7 ITIs and 14 SDCs under the Centrally Sponsored Scheme '**Skill Development in 34 Districts Affected by Left Wing Extremism**'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs. 25014000.00 (Rupees Two Crore Fifty Lakh and Fourteen Thousand only)** towards subsequent installment for establishment of 7 ITIs and 14 SDCs to the society "**State Project Livelihood College Society, Model ITI**" in the State of **Chhattisgarh** under the Centrally Sponsored Scheme '**Skill Development in 34 Districts Affected by Left Wing Extremism**', as detailed below:

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of **Rs. 250.14 Lakh (Rupees Rupees Two Crore Fifty Lakh and Fourteen Thousand only)** grant-in-aid for creation of capital assets to "**State Project Livelihood College Society, Model ITI**" under the State Government of Chhattisgarh is subject to the following terms and conditions:

- i The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
- ii The sanction is valid for one year from the date of issue.
- iii Subsequent release of fund will be made only after receipt of Utilisation Certificate (UC) from the State Government and sufficient utilisation of fund, subject to availability of fund.
- iv Sanction of grant is strictly restricted to the admissibility as per the decisions arrived in the meeting of Expenditure Finance Committee (EFC).

4. The State of **Chhattisgarh** is required to utilise the aid as per the guidelines of the scheme and furnish physical and financial progress reports as per the formats prescribed in the Implementation Manual.

5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, No.24(35)/PF-II/2012 dt29-08-2014.

6. The expenditure is debit-able to the Major Head 2230.03.796.09.04.35- Grant-in-aid for creation of capital assets.


7. Section Officer (Cash Section)/ Drawing and Disbursing Officer, DGT, Ministry of Skill Development and Entrepreneurship will draw the amount sanctioned vide para 1 above for Rs. 250.14 Lakh and pay Rs.250.14 Lakh to the below mentioned society by transferring electronically to the bank account of the society. The details of the society are given below:
