 - (vii) Annual Audited Financial Statements of the project should be submitted within 4 months after the end of each fiscal year.
- 5. State of Chhattisgarh, vide Letter no. DET/CoE/VTIP/UC/2014-15/2803 dated 1.06.2019 has confirmed utilization of central share of Rs. 50 Lakh out of Rs. 50 Lakh released to them prior to the fund being released now. (Copy of U/c attached).
