I am directed to convey the sanction of the President of India to release an amount of Rs. 0.23 Crore (Rupees Twenty Three Lakhs only) towards 30% advance of the fund allocated to the State for incurring the expenditure under the component Result Area 2 (RA-2) - Increased capacities of State Governments on signing of Performance Based Funding Agreement (PBFA) under the project "Skill Strengthening for Industrial Value Enhancement (STRIVE)" with World Bank assistance.

- 4. The expenditure of the released fund in respect of the World Bank assisted project STRIVE should be in accordance to the guidelines mentioned in the Operations Manual and subject to the following conditions:
 - (i) The grant shall be utilized for the activities mentioned in the Operations Manual for Result Area -2 and no portion of it shall be spent on any other purpose.
 - (ii) The grant should be utilized before close of project STRIVE and any amount not spent by that time should be surrendered to the Central Government.
 - (iii) The conditions mentioned under PBFA should be adhered to during project implementation.
 - (iv) It should be ensured that the agreed documents as per Disclosure Management Framework are disclosed on the website of SPIU/State Directorate.
 - (v) All documents must be retained by the State Govt. for post review by the World Bank.
 - (vi) Utilization Certificate in Form GFR 12-C of GFR 2017, indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.

This issues in exercise of the delegated powers in concurrence with the IFD, Ministry of Skill Development & Entrepreneurship vide AS & FA Dy. No.15003 dated 17.10.19 and approval of Secretary, MSDE vide FTS No.15003 dated 30.10.2019.
