Sub: Sanction for Release of Grants-In-Aid to the State of Nagaland towards establishment of State Apprenticeship Cell (SAMC) under Skills Strengthening for Industrial Value Enhancement (STRIVE) World Bank assisted Project during the FY 2020-21- regarding.

Sir,

I am directed to convey the sanction on the behalf of the President of India for the release of **Rs. 22.30 Lakh (Rupees Twenty Two Lakh Thirty Thousand only)** as Grants-In-Aid to the State of **Nagaland** for establishment of State Apprenticeship Monitoring Cell (SAMC) under Skills Strengthening for Industrial Value Enhancement (STRIVE) World Bank assisted Project during the FY 2020-21.

2. The Grants-In-Aid is being released subjected to the following terms conditions:
 - (i) The Grant-In-Aid is to be utilized only for the purpose for which it is released.
 - (ii) SAMC Guidelines issued vide letter no. **DGT-1(27)/D1/SAMC/2017-AP dated 26.12.2018** and orders issued by DGT from time-to-time to be strictly followed.
 - (iii) Utilization Certificate in form GFR 12C in duplicate be kindly furnished immediately after utilization fund. It should be certified that the compliances have been met with while incurring the expenditure.
 - (iv) The sanctioned fund stated at para-1/above fund must be utilized within March 2021 or closure of STRIVE scheme whichever is earlier as notified from time to time.
 - (v) State/UT Government must ensure proper utilization of the fund.
 - (vi) Quarterly Interim unaudited financial reports as per report format under STRIVE must be submitted by the State/UT at the end of every quarter.
 - (vii) Unspent amount, if any will be adjusted against future sanction.
3. The expenditure is debitable to the Major Head MH-3601-Grants-In-Aid under the component GEN, SCPSC & TSP from the Budget provision under Grant No.91-MSDE during FY 2020-21 as specified below:


