G.S.R. \_\_\_\_\_(E).- In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the Ministry of Labor , Directorate General of Employment and Training, (Group 'C' Technical posts) Recruitment Rules, 2003 notified vide GSR 100 dated 19-Feb-2003 and amendments notified vide GSR No. 345 dated 30.09.2004 and GSR No. 298 dated 24.08.2005, **except** as respect things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Group 'B' Technical (Non-Gazetted), in the Directorate General of Training (Except Women Training) under Ministry of Skill Development and Entrepreneurship, namely:-

1. **Short title and Commencement.** - (1) These rules may be called the Ministry of Skill Development and Entrepreneurship, Directorate General of Training (Except Women Training) , Group 'B' Technical post (Non-Gazetted), Recruitment Rules, 2023.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. **Application:** -  
These rules shall apply to the post mentioned in Column I of the Schedule annexed to these rules.
3. **Number of posts, classification, and Level in the pay of Matrix** - The number of posts, their classification **and Level in the pay of Matrix** attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
4. **Method of recruitment, age limit and other qualifications, etc.**- The method of recruitment, age limit, qualifications and other matters relating to the said posts, shall be as specified in columns (5) to (13) of the aforesaid Schedule.
5. **Disqualification - No person,** -  
(a) who has entered into or contracted a marriage with a person having a spouse living;  
or  
(b) who having a spouse living, has entered into or contracted a marriage with any person, shall be ineligible for appointment to any of the said posts: provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rules.

6. **Power to relax** - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by an order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
7. **Saving** - Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen, other backward classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Skilled worker, Junior Maintenance Mechanic, Photographer or Projectionist in the pay level-5 (Rs. 29,200 to Rs. 92,300/-) (Equivalent to grade pay Rs. 2800/- as per 6<sup>th</sup> CPC) with six years regular service in the grade and possessing the education qualification as prescribed under Column (8) will be considered for promotion to the post of Vocational instructor/Junior Technical Assistant/ Maintenance Electronics/Maintenance Electrician.
- b. Assistant Store keeper/Tool Store In-charge in the pay level-4 (Rs. 25,500/- to Rs. 81,100/-) (Equivalent to grade pay Rs. 2400/-) and possessing the qualification as prescribed under column (8) with ten years' regular service the grade in the unit and fulfilling trade requirements will be considered for promotion to the post of Store Keeper.

**Note 1:** Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their senior shall be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or 2 years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

**Note 2:** For the purpose of computing minimum qualifying service for promotion, the service rendered on regular basis by an officer prior to the 1st day of January, 2016 or the date from which the revised pay structure based on the Seventh Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding pay or pay scale extended base on the recommendation of the Pay Commission.

**Deputation:** Officers of the Central Govt. or State Government or Union territories.

- a. (i) Holding analogous post on regular basis in the parent Cadre or Department.  
Or  
(ii) with six years' service in the grade rendered after appointment thereto on regular basis in pay level- 5 (Rs. 29,200/- to Rs. 92,300/-, Grade pay of Rs.2800/- in 6<sup>th</sup> CPC) in the parent cadre or department.
- b. Possessing the education qualification and experience as prescribed for Direct recruits under Column (7).

Including Short Term Contract (ISTC): -

- a. B.E./Diploma in engineering with 01-year experience in teaching or industry.  
Or
- b. National Trade Certificate (NTC) and National Craft Instructor certificate (NCIC) with 03 years' experience in teaching or industry.

**Note 1:**

1. The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

2. Period of deputation (Including Short Term Contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not to exceed three years.
3. The maximum age limit for appointment by deputation shall be 'Not exceeding 56 years' as on the closing date of receipt of applications.
4. For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 1st January, 2016 or the date from which the revised pay structure based on the Seventh Pay Commission recommendation has been extended, shall be deemed to be service rendered in the corresponding pay level or pay scale extended based on the recommendations of the Pay Commission.
