 - (vi) Utilization Certificate in Form GFR 12-C indicating expenditure incurred under the scheme should be furnished to DGT in Duplicate.
 - (vii) Annual Audited Financial Statements of the project should be submitted within 4 months after the end of each fiscal year.
- 5. State of Haryana, vide letter no. P-1/SPIU/Salary/STRIVE/4556 dated 14.02.2019 has confirmed utilization of central share of Rs. 6.62 Lakh out of Rs. 7.16 Lakh released to them prior to the fund being released now. (Copy of U/c attached).
