Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to Rs.250.00 Lakh (Rupees Two Crore and Fifty Lakh only) towards partial fulfillment of 1st installment for Upgradation and Supplementing Deficient Infrastructure of existing ITIs in the State of Manipur under Centrally Sponsored Scheme "Enhancing Skill Development infrastructure in NE States" as detailed below:-

- 2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.
- 3. The release of Rs. 250.00 Lakh (Rs. Two Crore and Fifty Lakh only) as grant-in-aid for Upgradation and Supplementing Deficient Infrastructure of existing ITIs to the State of Manipur is subject to the following terms and conditions:
  - i. The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
  - ii. Utilisation Certificate should be submitted online through EAT module of PFMS, component wise, year wise expenditure statement may be furnished immediately after utilisation. State also should submit Utilisation Certificate as per 12C format of GFR 2017.
- iii. The Sanction is valid till the completion of project period.
- iv. All the purchases will be made in accordance with the State Govt. norms.
- v. Utilization of fund will be assessed by monthly progress report, field visits, photograph/ videos etc.
- vi. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.

- A separate maintenance contract including annual white wash of building, repairs of all electrical nature, plumbing as required, maintenance of lawns, gardening, sports facilities etc. may be made vii. part of the construction contract.
- Specific efforts to be made to increase enrolment of women, including publicity drives, education viii.
- Specific physical and financial mile stones with corresponding half-yearly targets for their implementation may be provided. In the event of any slippage from adherence of these specific ix. target at the end of every six months, monitoring division apprised of the reasons for slippage along with strategy to achieve the targets.
  - Accessibility features must be provided in all new constructions. Old buildings must be retrofitted. This must be adhered to irrespective of the presence/ absence of any student with disabilities. x.
- Possibility of disbursal linked indicators may be explored for new hostels. xi.
- A compulsory module in entrepreneurship may be added to all existing courses to provide capacity xii. building for self-employment.
- Training / attachment with industry may be made essential. xiii.
- 4. The State of Manipur is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.
- 5. It has been observed that instead of concrete/bricks, boundary walls at Senapati, Ningthouknong, Phaknung, Tamenglong and Chandel ITIs are erected as fencings made of barbed wire and wire mesh. Government of Manipur is advised herewith to erect concrete/bricks, boundary walls instead of fencings made of barbed wire and wire mesh, otherwise an amount of Rs. 247.35 lakh (Rs. 196.49 lakh has been allocated for Boundary wall + Rs. 107.00 lakh has been released to Manipur State for boundary wall in ITIs at Senapati, Ningthouknong, Phaknung, Tamenglong and Chandel) will be deducted from the last instalment that will be released for the component "Upgradation of existing ITIs" and "Supplementing Deficient Infrastructure" under the ESDI scheme.
- 6. The sanction is in accordance with the aid appraised by the appropriate appraisal forum Expenditure Finance Committee (EFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance- II Division OM NO.1(3)/PF-II/2001 dt1.4.2010.
- 7. The expenditure is debit-able to the Object Head 3601.06.101.36.07.35- Grants for creation of capital assets as per the para 1 above.
- 8. The amount of Rs. 250.00 lakh (Rs. Two Crore and Fifty Lakh only) may be transferred to the Government of Manipur through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II(45/76/SC) Dated 22-02-1977.
- 9. As per Department of Expenditure, Ministry of Finance's O.M. No F.No. 1(13)PFMS/FCD/2020 dated 23.03.2021, the State Government will transfer the Central Share received in its account in the RBI to the Concerned Single Nodal Agency's (SNA's) account within a period of 21 days of receipt.
