I am directed to convey sanction of the President of India to incur an expenditure not exceeding to <u>Rs. 500.00 Lakh (Rupees Five Crore only)</u> as One Time Grant for 5 Institute Management Committees (IMCs) @ Rs. 100.00 lakh per IMC in Malkangiri, Rayagada, Deogarh, Gajapati and Sambalpur districts in the State of Odisha under the Centrally Sponsored Scheme 'Skill Development in 47 Districts Affected by Left Wing Extremism', as detailed below and subject to the conditions stated:

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of **Rs. 500.00 Lakh (Rupees Five Crore only)** as One Time Grant for 5 Institute Management Committees (IMCs) @ Rs. 100.00 lakh per IMC in Malkangiri, Rayagada, Deogarh, Gajapati and Sambalpur districts in the State of Odisha is subject to the following terms and conditions:

- i. The fund is being released as one time grant and shall be spent for Recurring purposes or as admissible as per the SFC. The fund should be utilized with compliance of Section 'F' of MoA under the scheme.
- ii. Utilisation Certificate issued to DGT in form GFR-12C and component wise, year wise expenditure statement may be furnished immediately after utilisation.
- iii. This is one time Grant. No extra Grant will be released in future for above mentioned IMCs.
- iv. The Sanction is valid in current financial year 2020-21 i.e. upto 31" March, 2021.
- v. All the purchases will be made in accordance with the State Govt. norms.
- vi. Utilization of fund will be assessed by monthly progress report, field visits, photograph/ videos or whichever means is applicable.
- vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.

4. The Odisha State is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.

5. The sanction relates to the Plan expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Expenditure Finance Committee (EFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance-II Division OM No. 1(3)/PF-II/2001 dt. 01.04.2010.

6. The expenditure is debit-able to the Major Head 3601.06.101.36.07.31 - Grants in Aid – General.

7. The amount of Rs.500.00 Lakh (Rupees Five Crore Only) may be transferred to Government of Odisha through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) Dated 22-02-1977.

8. Certified that no utilisation certificate is pending in respect of the State mentioned in the sanction order as per requirement.

9. This is one time Grant for IMC for 5 districts i.e. Malkangiri, Rayagada, Deogarh, Gajapati and Sambalpur.

10. This issues in exercise of the delegated powers and in concurrence with the IFD, Ministry of Skill Development & Entrepreneurship vide AS&FA FTS No. 36834 dated 26.10.2020.
