As you are aware, the Directorate General is making continuous efforts to enhance the skills and employability of trainees and trainers through its network of 33 National Skill Training Institutes (NSTIs) and more than 14,000 Industrial Training Institutes (ITIs). Now, subsequent to the series of discussion we had in this regard, it is informed that we may start a pilot programme for training in Optical Fiber Technology for the NSTI/ITI trainees in the following institutes:

As per the discussion, initially, the CTS/CITS trainees who are appearing/passing-out in 2022 examination in trades/ courses such as Electronics Mechanic, Mechanic Consumer Electronics Appliances, IoT Technician (Smart City), IoT Technician (Smart Healthcare), Smartphone Technician cum App Tester, Information & Communication Technology System Maintenance, Electrician and Fiber-To-Home-Technician, will undergo the 3-5 days training to be conducted by your organization. Assuming 25 trainees are trained / week, about 100 trainees from each location will be trained every month.

3. Further to our discussion, the infrastructure support in form of furnished classrooms, labs, high-internet connectivity, etc. and administrative support will be provided by the institutes while RJIL will provide the tools & equipment (kits), other consumable items, internet connectivity across the campus (wherever slow / no connectivity available) and other necessary support for conducting the training. Assessment of the trained candidates would be conducted by the RJIL Team on the NSTI premises and certification will be done jointly. RJIL will provide placement support to the trained students.

4. In this regard, the concerned Regional Directors have been directed to mobilize the trainees from relevant trades through the State Directorates also and your relevant support for the same will be much appreciated.
