#### NOTIFICATION

G.S.R.-----In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Directorate General of Training (Class III and Class IV) Recruitment Rules, 2011 the President hereby makes the following rules regulating the method of recruitment to the post of "Multi Tasking Staff" in the Directorate General of Training, Ministry of Skill Development and Entrepreneurship, namely:-

- 1. Short title and commencement (1) These rules may be called the Directorate General of Training, Ministry of Skill Development and Entrepreneurship, (Multi Tasking Staff) Recruitments Rules 2022.
  - (2) they shall come into force on the date of their publication in the Official Gazette
- 2. **Number, classification and scale of pay:** The number of the said post, their classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, other qualifications, etc. The method of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (14) of the said Schedule.
- 4. **Disqualifications** No person. -
  - (a) who has entered into or contracted a marriage with a person having a spouse living,
  - (b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so exempt any person from the operation of this rule.

- 5. Power to relax Where the Central Government is of the opinion that it is necessary or expedient to do so, it may by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving- Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Schedules Tribes, the Other Backward Classes, Ex-servicemen and Economical Weaker Sections and other special categories of persons, in accordance with orders issued by the Central Government from time to time in this regard.
