Subject : Release of Grant-in-Aid to the State of **West Bengal** for Skill Training in one district under the Centrally Sponsored Scheme '**Skill Development in 34 Districts Affected by Left Wing Extremism**'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs. 3.83 Lakh (Rupees Three Lakh and Eighty Three Thousand only)** as 2nd installment towards partial fulfillment for Skill Training in one district of Paschim Midnapur (Lalgarh Area) in the State of **West Bengal** under the Centrally Sponsored Scheme '**Skill Development in 34 Districts Affected by Left Wing Extremism**', as detailed below and subject to the conditions stated:

2. Further the above sanction is subject to the following conditions:

- The sanction is valid for one year from the date of issue.
- For one District, 30 youth in long Term training of 24 months duration, 120 youth in Short Term training of 3 months duration & 10 youth in Instructor training of 12 months duration are supported.
- Subsequent release of fund will be made only after receipt of Utilisation Certificate (UC) from the State Government and sufficient utilisation of fund, subject to availability of fund.
- Sanction of grant is strictly restricted to the admissibility as per the decisions arrived in the meeting of Expenditure Finance Committee (EFC).

3. The State of West Bengal is required to utilise the aid as per the guidelines of the scheme and furnish physical and financial progress reports as per the formats prescribed in the Implementation manual.

4. The sanction relates to the Plan expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Expenditure Finance Committee (EFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance-II Division OM No. 1(3)/PF-II/2001 dt. 01.04.2011.

5. The expenditure is debitable to the Major Head 3601 as per the following table:

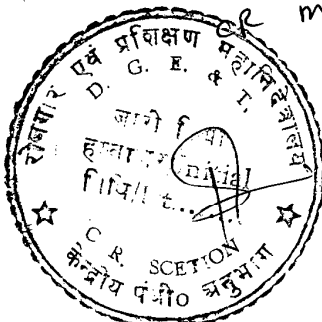
