
Subject: - **Revised Guidelines of Third Counseling for Admission in CITS for Session 2018-19**

Respected Sir/ Madam,

The following are the Revised Guidelines to be followed for Third counseling:-

1. Merit list for Third Counseling has been prepared by NIMI and uploaded on its Portal. All Institutes have to download the Merit list of third Counseling from the link provided by NIMI using the same User I.D. and password, which was forwarded to them and used for uploading the data of 1st and 2nd Counseling.
2. Third Round of Counseling will be from 29th August, 2018 to 4th September, 2018 (including Saturday and Sunday also).
3. Some of the Institutes may remain closed on 3rd September 2018 on account of Janmashtami. If in the State it is not declared closed holiday, then the Institute of DGT located in that state will remain open on 3rd September, 2018 also. Classes will start from 5th September, 2018 (Teacher's Day).
4. The Institutes must fill up the data of admitted candidates on NIMI link by 5th and 6th September, 2018. Thereafter NIMI will prepare Centralized list for 4th Round of Counseling.
5. The same committee which has been constituted by Director for conducting 1st and 2nd Counseling will be undertaking the 3rd Counseling also and check the certificate as well as other related documents during counseling. The Committee will prepare the list of Eligible candidates Trade wise after Counseling from the Merit list provided by NIMI. After approval of the Director (Chairman of the Committee) the selected candidates of list will be permitted to deposit the fees on the date of Counseling.
6. No Relaxation of Cut off Marks below 30/23 in respect of General and Reserved Category candidate will be allowed.
7. No admission to be made by ITOT's from outside of Centralized List.
8. **The Seating capacity (Trade wise) of the Institute are uploaded on the NIMI portal, so each Institute including the ITOT must ensure that they should not take admission in any trade more than the Seating capacity as specified on NIMI Portal.**
