Subject: Release of Grant-in-Aid to the State of Sikkim to implement the Centrally Sponsored Scheme 'Enhancing Skill Development Infrastructure in NE States'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs.3,95,00,000.00 (rupees three crore and ninety-five lakh only)** as subsequent installment for establishment of new ITI at Aritar and Chumbong in the State of Sikkim under the Scheme "Enhancing Skill Development infrastructure in NE States" as detailed below:-

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of **Rs.3,95,00,000.00 (rupees three crore and ninety-five lakh only)** as grants in aid for establishment of new ITI at Aritar and Chumbong in the State of Sikkim is subject to the following terms and conditions:

- The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
- Utilisation Certificate issued to DGT in form GFR-12C and component wise, year wise expenditure statement may be furnished immediately after utilisation by the State Government of Assam.
- The Sanction is valid till completion of the project period.
- All the procurements should be made through Government e marketplace(GeM) and in case of non-availability of the item on GeM portal , may be procured in accordance with the State Govt. norms of procurement.
- Utilization of fund will be assessed by monthly progress report, field visits, photograph/ videos etc.
- Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.

4. The State Government of Sikkim is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.

5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance- II Division OM NO.1(3)/PF-II/2001 dt1.4.2010.

6. The expenditure is debit-able to the Major Head 3601.06.101.42.00.35 - Grants for creation of Capital Assets and Major Head 3601.06.796.93.00.35 - Grants for creation of Capital Assets as per para 1 above.

7. The amount of **Rs. 3,95,00,000.00 (rupees three crore and ninety-five lakh only)** may be transferred to Government of Sikkim through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) Dated 22-02-1977.

8. As per Department of Expenditure, Ministry of Finance's O.M. No F.No. 1(13)PFMS/FCD/2020 dated 23.03.2021, the State Government will transfer the Central Share received in its account in the RBI to the Concerned Single Nodal Agency's (SNA's) account within a period of 21 days of receipt. The bank details of SNA's are given below:

9. The State of Sikkim should submit the UC after utilisation of fund as per format 12-C of GFR 2017.

10. Certified that no utilisation certificate is pending in respect of the State mentioned in the sanction order as per requirement.

11. This issues in exercise of the delegated powers and in concurrence with the Integrated Finance Division, Ministry of Skill Development & Entrepreneurship vide JS&FA FTS No.9217 dated 28.11.2023 and Secretary MSDE vide FTS No. 9217 dated 08-12-2023.
