The release of payment to DAVP from the NIMI A/c shall be in accordance with the approved procedure

3. The accounts of the NIMI shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Account Offices of the Ministry, whenever the Institution /Organization is called upon to do so.

4. An audited statement of account (in duplicate) shall be furnished to this Ministry within three months from the close of the financial year showing inter-alia a complete picture of the Institute's finances.

5. The Grant will be utilized to meet the expenditure of NIMI, Chennai for FY 2022-23. The Government's directives issued from time to time should be strictly following for incurring any expenditure.

6. A utilization certificate in respect of the total grant paid to the Institute by the Government shall be furnished.

7. The Grant is non-recurring type and noted at MH "2230" serial no. 01 (FY 2022-23) in the register of Grants placed in the NPIU Sanction.

8. The assets acquired by the institute wholly or substantially out of the Government grants will not without prior sanction of the Government, be disposed of encumbered or utilized for purposes other than those for which grants are

sanctioned. Further, a separate account of such assets will be maintained in Form GFR 12-A and an annual return submitted to the Government.

9. The institute will ensure that reservation for Scheduled Castes and Scheduled Tribes in the post/ service under its control are maintained on the lines indicated by the Government of India.

10. The expenditure involved is debatable to Major Head "2230" GIA for F.Y. 2022-23 under the Scheme "Skill Strengthening for Industrial Value Enhancement (STRIVE) with World Bank Assistance".

11. The aforementioned project is a new project for which funds are being released to NIMI for the first time, hence no UC is required in this regard.

12. No interest is accrued as first time fund has been released for this project.


13. This sanction issues with concurrence of **IFD Division** of MSDE, vide Note#103 dated 16.09.2022 of **JS & FA** and approval of **Secretary** MSDE vide Note#102 dated 16.09.2022, E-file No. **49296**.
