The amount of **Rs. 3,94,40,464/- (Rupees Three Crore Ninety Four Lakh Forty Thousand Four Hundred Sixty Four only)** will be credited to the IIE, Guwahati account with the "Bank of Baroda, BELTOLA Branch, Guwahati-781029". 3. The accounts of the IIE, Guwahati shall be open for inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Account Offices of the Ministry, whenever the Institution /Organization is called upon to do so.
4. An audited statement of account (in duplicate) shall be furnished to this Ministry within three months from the close of the financial year showing inter-alia a complete picture of the Institute's finances.
5. The Grant will be utilized to meet the expenditure of IIE, Guwahati for FY 2023-24. The Government's directives issued from time to time should be strictly following for incurring any expenditure.
6. This grant is being paid first time to the institute for this work, therefore no utilization certificate is pending.
7. A utilization certificate in respect of grant paid to the Institute by the Government for this work shall be furnished.
8. The Grant shall be used as per the provisions of GFR.
9. The Grant is non-recurring type and noted at MH "2230" serial no. 13 (FY 2023-24) in the register of Grants placed in the NPIU Sanction.
10. The interest accrued in the Bank Account mentioned is to be deposited in the Bharatkosh (CFI).
11. The assets acquired by the IIE, Guwahati wholly or substantially out of the Government grants will not be disposed of without prior sanction of the Government or utilized for purposes other than those for which grants are sanctioned. Further, a separate account of such assets will be maintained in Form GFR 12-A and an annual return submitted to the Government.
12. The expenditure involved is debitable to Major Head "2230" and sub-heads 2230.03.102.22.00.31-General, 2230.03.789.11.00.31-SCSP & 2230.03.796.13.00.31-TSP during F.Y. 2023-24 under the Scheme "Skill Strengthening for Industrial Value Enhancement (STRIVE) with World Bank Assistance".


